**NOTICE INVITING e-AUCTION SALE-GM/PW/NIA-2/2018-19 Dt.07.08.18 OF THE

Sealed bids are hereby invited on "AS IS AND WHERE IS BASIS" by the Chairman, Gayeshpur Municipality, on behalf of the Board of Councillor, from bonafied bidders for Auction sale of Earth diposited at the Road flank from Gayeshpur 7 No. more to Gayeshpur Cheek post more within Gayeshpur Municipality Chainage km. 2.80 to Km. 5.60 Km.of Gayeshpur Municipal Main Road.

All concerned are requested to access the website <http://eauction.qov.in/> for this auction.

TERMS & CONDITIONS OF AUCTION SALE

1. The intending bidders should possess valid PAN,GST, acknowledgement receipt of payment of P.Tax, current I.T. return, current Trade Licenses (2018-2019) and upload on line self attested scanned copies of all the documents as indicated in the web site, otherwise no approval will be given.
2. 'STARTING PRICE' as indicated in the e-auction notification published, may not be considered as the 'RESERVE PRICE for the earth per cu.m. has been fixed by the competent authority and the same has been kept confidential. The highest bidder will be considered on the basis of the Reverse price fixed by competent authority and not on the basis of the starting price.
3. Earnest Money : Rupees 50000.00(Rupees Fifty thousand) only for the lots of earth, in form of Bank Draft from of any nationalized bank, drawn in favour of the "Chairman, Gayeshpur Municipality, P.O. Kataganj, Nadia, against the work, scanned copy of which has to be uploaded on line in between "DOCUMENT SUBMISSION/PAYMENT START DATE" i. e 07.08.2018 and DOCUMENT SUBMISSION / PAYMENT END DATE' i.e 14.08.2018. After opening bids, earnest money of all intending bidders except highest bidder (H1) & second highest bidder (H2) will be refunded, after due sanction is obtained from the competent authority. However earnest money of the second highest bidder (H2) will be refunded only after the acceptance of work order by H1. This clause is applicable for all categories of applicants, No bid will be accepted without earnest money. The original bank draft will have to be submitted at the office of the Chairman, Gayeshpur Municipality, P.O. Kataganj, Nadia, latest by the 'DOCUMENT SUBMISSION / PAYMENT END DATE', i.e 14.08.2018 otherwise the on line will not be accepted by this office.
4. 100% bid amount as decided by the agency ,will have to be deposited by the agency / firm before collection of goods and within 7(seven) working days of the issue of letter of acceptance, failing which earnest money shall stand forfeited. under Chairman, Gayeshpur Municipality, P.O. Kataganj, Nadia, for a minimum period of one year.
5. The earnest money deposited by HI will be refunded only after satisfactory completion of work certificate is furnished by the officer in charge.
6. The intending bidders must provide every details as desired above including his name, address and Mobile no. and office land line no. if available, clearly in the space provided for the same-online. Incomplete information may lead to rejection.
7. Auction items to be collected from mentioned addresses at the purchaser's own arrangement (viz. loading into vehicle, transporting and others). No expenses in any form towards disposal will be borne by the office.
8. Road challan for disposal will be provided by the Site Incharge, Gayeshpur Municipality, P.O. Kataganj, Nadia. However all other permits/permissions required for transportation and disposal will have to be arranged by the purchaser. Disposal of the materials/goods have to be relevant traffic rules of the area. All such type of incidental costs have to be considered by the bidders while quoting their bid/offer.

9. The successful bidder at his own cost has to adopt all safety/preventive/precautionary measures following relevant rule of the Government for safe disposal of items. Permission from appropriate authority if needed for such process has to be procured from the end of the bidder at his own cost, failing which the earnest money of the bidder will be forfeited.

10. In general the highest bid will be accepted. However, the bid inviting authority shall not be bound to accept the highest bid and can go for subsequent calls if the highest bid in the opinion of the undersigned does not appear to be satisfactory, the undersigned reserves the right to hold fresh bids and so on. The bid inviting authority will issue lifting order to the successful bidder whose rates stand highest.

11. The site from 2.80 to Km. 5.60 Km. at the Municipal Municipal Main Road Which may be viewed between 12.00 Hrs to 16.00 Hrs on any working day with the permission of the Concerned authority. Bid may be placed after physical verification.

12. Bids placed by the agency (H-1) will be accepted as per terms and condition laid down vide Govt. of West Bengal, Finance department order No. 4068-F(Y) dt. 25.05.2015.

13. All precautionary measures will be taken by the auctioneer so that no damage to any Government property or personnel takes places. Under no circumstances, dismantling measure which can cause a fire hazard will be permitted. Any damage or loss of Government /public/private property or life during the dismantling/disposal process will be the sole responsibility of the successful bidder and the successful bidder has to replenish the cost of such damage at his own cost as per estimate prepared by this office, failing which the earnest money of the bidder will be forfeited.

14. The dates and times published on line are final and no request for any change will be entertained under any circumstances. Moreover, no objection in any form shall be entertained after completion of online security of documents.

15. The order would be treated as valid for 120 (Hundred Twenty) days from the date of opening of the on line bid and the lifting order (hard copy), may be issued on any day within such 120 (Hundred Twenty) days period. The successful bidder has to complete the work in all respects within next 120 (Hundred Twenty) days from the date of issuance of such lifting order.

16. All auctioned materials have to be removed from the site within 120 (Hundred Twenty) days from the date of issuance of lifting orders, failing which the earnest money will be forfeited without issuing any further notice and the lifting order will stand cancelled

17. Permission will be given to any application to participate in auction only. Any individual possessing more than one(01) firm / agency by the same proprietorship can participating in one(01) auction only.

18. It shall be deemed that all bidders have thoroughly read and understood the terms and condition of sell efore bidding. It will also be deemed that all the bidders have inspected the properties prior to auction and have satisfied themselves with the full particulars of the same. No objection or claim of any nature whatever shall be entertained at the conclusion of the auction. The online bids to be submitted accordingly.

19. Failure on the part of any bidders to observe and abide by any or above noted terms and conditions will disqualified himself to become eligible Bidders and his earnest money or part thereof as necessary may stand forfeited to the authority.


20. The auction inviting authority reserves the right to accept or reject to any or all of the Bids without assigning any reason thereof.
